- g) Defibrillators and bleed kits – to include update on installation of new cabinets and acknowledgement of known issues with one model, and possible other installation.
- h) Bus shelters and street furniture – to include update on grit bin at Market Place and consideration of a request for a new grit bin at Francis Road
- i) Maintenance equipment
- j) Other parish owned land including Market Place, Broadwell, Village Green – to include update on the Oaks at 80 project, also consideration of the reinstatement of the missing mile post at Black Dog.
