22/23-219	Apologies for Absence Cllr Vine and Cllr Fraser had sent apologies due to personal commitments, which were accepted. Absent Cllr Andrew.

22/23-221	<b>Minutes of Council Committee meeting</b> The minutes of the HRAF committee meeting held on the 22nd November 2022, having been previously circulated to members, were approved, and signed as a correct record (proposed Cllr Stevens, seconded Cllr Taylor).
22/23-222	Adjournment for Public Participation (maximum of 5 minutes) The meeting was adjourned and resumed at 7.31pm.
22/23-223	<ul> <li>Update on actions agreed at last or previous meetings <ul> <li>a) Pavilion Fire Risk assessment – Cllr Davis reported that he would be carrying out a second visit tomorrow, after which he would finalise his report and circulate to members.</li> <li>b) Footpath signs / way markers – Cllr Davis provided details of the two quotes obtained. Following further discussion, it was proposed by Cllr Stevens, seconded by Cllr Steele, and resolved to approve the quote from Kennet Signs of £353.80 + VAT plus artwork charge (quote provided some time ago, so maybe subject to change) – ACTIONS – Cllr Davis to obtain firm quotes and place order with Kennet Signs.</li> <li>c) MLAV7 (Spin Hill phone box to Dauntsey Drive) and use of scalpings to improve the surface – The Clerk reported that she was still awaiting a response from the Wiltshire Council Rights of Way Department. Cllr Osborn noted that the footpath MLAV15 from Drove Lane passed the Cemetery could also do with some scalpings – ACTIONS – Clerk to follow up.</li> <li>d) MLAV 8 (Dauntsey Drive to MLAV6 near Wick Farm) and MLAV3 (Russell Mill Lane to Wick Farm) – Cllr Davis reported that the stile repairs would be carried out after April when the new Parish Steward Contract had been finalised. The 'bull in field' sign had now been removed.</li> <li>e) Elisha Field Play Area frog climbing board – Cllr Osborn estimated that the cost to repair and re-instate the climbing board would be approx. £65, and offered to carry out the work. 22/23-224	Wiltshire Council LHFIG Committee in January
	<ol> <li>Investigate the feasibility of widening the two sections of pavements along the pinch points at either end of the village, and installing traffic lights to manage vehicle flows and avoid gridlock – The Parish Council had been advised that funding for the project would need to be bid for from the Substantive Scheme, and it had been asked to consider splitting the scheme into two separate projects. The Parish Council would also be expected to contribute a minimum of 25% towards the cost of the initial feasibility study.</li> </ol>
	Following further discussion, it was recognised that the physical layout of buildings at the Church Street end of the village meant it was impossible to widen the road/pavement at this point, and this would therefore appear to be the most appropriate project to progress with first. A suggestion was then received regarding creation of a possible alternative pedestrian route behind the houses on Church Street, which is was agreed merited further investigation before a final decision was made regarding priorities – <b>ACTIONS</b> – Cllr Osborn to review feasibility of suggestion and report back at next Parish Council meeting. Clerk to follow up with Conservation Officer regarding pinch-
	<ul> <li>point at other end of the village.</li> <li>Addition of 'flashing' warning lights to 'School' triangular warning sign on the approach to Drove Lane from Easterton – The Parish Council had been advised that if the school has a 'Travel Plan' funding can be sought from a different Wiltshire Council budget. Dialogue with the School and Wiltshire Council had provided some additional information which was provided to members – ACTIONS – Clerk to follow up enquiries with Wiltshire Council regarding feasibility of the location for a flashing sign, and discuss the 'School Travel Plan' with St Barnabas.</li> </ul>
	3) Supply and installation of NAL socket and post at end of Church Street (end nearest to Community Hall) - The Parish Council had been advised that funding for the project would only be considered if there was an active Community Speedwatch Team.
